Divorce Request Information Pack**

This document contains the form which you will need to complete and send back to LGSS Pensions Service if you require a valuation of your accrued pension rights with Northamptonshire Fire and Rescue Service.

It also contains other information which will be of use to you and/or your solicitors. Please read the information carefully.

In order that I can provide you with the personal information you require, please complete and return to me the attached form FDIVF01 as quickly as possible. This will give me your written authority to provide you (and your solicitor if you so wish) with all the pensions information that will be necessary for proceedings relating to divorce or dissolution of civil partnership. It may be the case that certain information has to be gathered from other sources before I can provide you with the information you require, eg pay details have to be obtained from your employer and your Guaranteed Minimum Pension figure has to be obtained from HM Revenue & Customs. If I experience any difficulty in obtaining information from other sources, I will let you know.

I suggest that you inform your solicitor if you have any other pension rights that you have not transferred to either the FPS or NFPS administered by LGSS Pensions Service on behalf of Northamptonshire Fire and Rescue Service. This would include any pension rights you have in another pension scheme, any pension rights where a transfer to the FPS 1992, FPS 2006 or FPS 2015 is currently being negotiated, or any free-standing additional voluntary contribution plan you may have.

A schedule of charges that may apply has been attached. In most cases, there will not be a charge. However, if you are already in receipt of a pension, or you have made a previous request in the last 12 months, then an invoice may be sent to you for payment before any calculations can be completed.

Please note that under the Pensions on Divorce etc (Provision of Information) Regulations 2000, I may also be required to provide similar information directly to the Court if so ordered and certain information (excluding a valuation of your pension benefits) to your spouse / civil partner if requested to do so.
